DEBBIE HARRIS, OFFICIAL DIGITAL REPORTER

1           MS. JOHNSON: I had asked that this case be set for  
2 docket sounding. However, I did realize, while I was  
3 sitting in court, Mr. Rosier just returned from Florida  
4 State Hospital. His first court appearance was last  
5 month, in July. I was out on medical leave, and Mr. Ream  
6 was covering for me. We have not had a competency  
7 hearing for Mr. Rosier. I ask that we set that so that  
8 -- we're not disputing the competency -- but I ask that  
9 we set that first, prior to setting it for trial.

10           MR. FUCHS: If you stipulate, we can do it right  
11 now. Your Honor, if there's a stipulation as to his  
12 competency, that can be done per stipulation, then the  
13 Court can rule on it.

14           MS. JOHNSON: We're stipulating that he's competent.  
15 He's not present, but I would prefer him to be present.  
16 If we can reset it for court tomorrow, so that we can


