**APPELLEE'S SECOND UNOPPOSED MOTION FOR EXTENSION OF  
TIME (15 Days) TO FILE ANSWER BRIEF**

pursuant to Fla. R. App. P. 9.300, hereby moves for a 15-day extension of time (until  
September 12, 2017) in which to file its Answer Brief and states:

1. Currently, the deadline for Appellee to file its answer brief is Monday,  
August 28, 2017.
2. Due to counsel's calendar, a 15-day extension of time (until September  
12, 2017) is necessary for Appellee to complete and file its answer brief.
